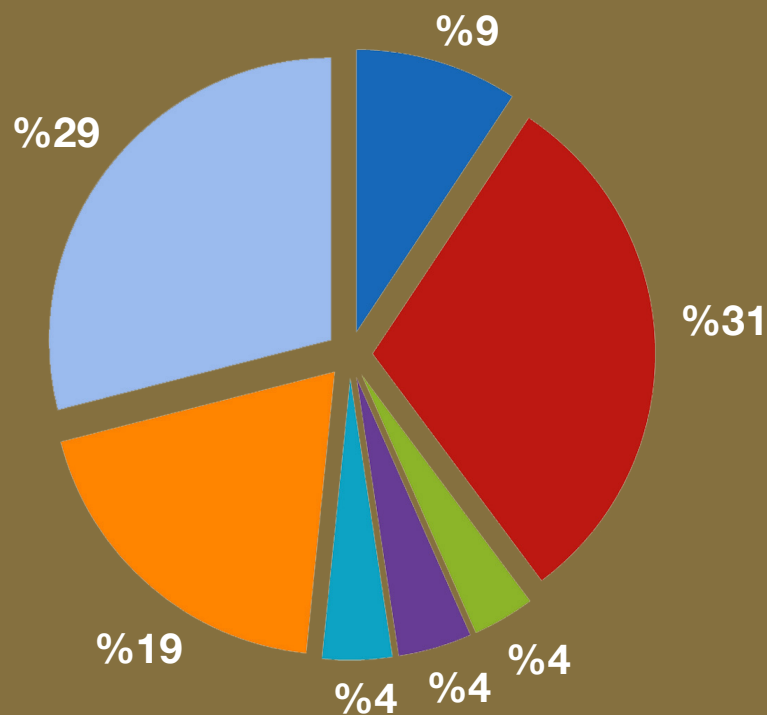

Educating the Public

Through outreach efforts and a proactive strategy, TCA works to ensure accurate and balanced media portrayals of Turkish Americans and Turkey.

Throughout 2015, TCA's team monitored American, Turkish, and international media. TCA staff engaged with journalists through in-person meetings and by providing fact sheets and information about both history and current events regarding Turkish Americans and Turkey.

TCA has held numerous background meetings with senior reporters, editors, and contributors from some of the world's largest publications and news agencies. These meetings provide an open forum for reporters and editors to learn more about U.S.-Turkey relations, Turkey's role in global affairs, and current issues facing Turkey and Turkey's region. Through these dialogues, TCA also gives journalists information about TCA's initiatives and views on relevant issues. TCA President G. Lincoln McCurdy's "Turkey's Safe Harbor" Op-Ed was published by The Hill in 2015.

TCA Issue Papers provide opinion leaders and members of Congress with information and analysis on current issues related to Turkey. In 2015, TCA released 16 Issue Papers and statements that detailed current affairs related to Turkey and TCA's positions.

TCA received consistent coverage in U.S. media outlets in 2015 and was a primary reference for reporters to consult for a Turkish American perspective. TCA was quoted or featured in several press publications, including The New York Times, Hurriyet, Hurriyet Daily News, Milliyet, The Hill, Daily Sabah, Indian Country Today Media Network, and others in the U.S. and Turkey.

Another source of information for the general public is the [TCA website](#), which features topical as well as in-depth information on issues concerning Turkish Americans and U.S.-Turkey relations. The website features an extensive compilation of reference materials, talking points, and resource and reading lists on Turkey. In 2015, the TCA website received 1,354,456 hits.

In 2015, TCA continued its social media campaign to expand its online presence. In the last year, TCA's [Twitter](#) and [Facebook](#) profiles reached thousands of people.

TCA WASHINGTON SUMMER INTERNSHIP PROGRAM

The [TCA Washington Summer Internship Program](#) provides young Turkish American college students and recent graduates the opportunity to work in Washington, DC as interns with members of the U.S. Congress and select governmental and non-governmental organizations. The program aims to foster young Turkish Americans' interest in public affairs and service as well as enhance their knowledge of American political life. It also seeks to prepare future Turkish American political and community leaders.

Since the TCA Washington Summer Internship Program began in 2007, it has provided a total of 146 internship opportunities to Turkish Americans, with 13 Turkish Americans participating in the 2015 program. Outside of the Washington Summer Internship Program, TCA also had six other interns, including one Bosnian American.

In Congress, the 2015 TCA Turkish American interns worked in the offices of Representatives Brendan Boyle (D-PA/13th), Frank Guinta (R-NH/1st), Alcee Hastings (D-FL/20th), Bill Pascrell (D-NJ/9th), Ileana Ros-Lehtinen (R-FL/27th), and the Democratic National Committee. In addition, TCA placed interns at the American Turkish Association of Washington, DC (ATA-DC), American Turkish Council (ATC), Assembly of Turkish

American Associations (ATAA), Atlantic Council, Middle East Institute (MEI), Quality Trust, and the Washington offices of the Turkish Industry and Business Association (TUSIAD) and the Union of Chambers and Commodity Exchanges of Turkey (TOBB).

As a part of the 2015 Washington Summer Internship Program, TCA hosted the annual TCA Summer Intern Orientation Session at its Washington, DC office. Interns gathered for a day of professional development and briefings with the Embassy of Turkey, representatives from Turkish American organizations, and former TCA summer interns. Orientation participants also met with two former members of Congress, Dan Maffei (D-NY) and Ken Kramer (R-CO), who discussed activism and political engagement. The day culminated in a meeting with Dr. Kemal Kirisci of the Brookings Institution and Dr. Kadir Ustun of SETA Foundation, who discussed U.S.-Turkey relations and Turkish politics.

In 2015, TCA also began a new partnership with the Atlantic Council to provide Turkish Americans with educational opportunities in global affairs and public policy through TCA internships at the Atlantic Council. Opportunities for the Atlantic Council internship through TCA were available throughout the year.

TCA TURKISH AMERICAN YOUTH LEADERSHIP CONGRESS

A new addition to the TCA flagship programs for Turkish American youth is the [Turkish American Youth Leadership Congress](#), which was held in Washington, DC on November 5-8, 2015.

The TCA Turkish American Youth Leadership Congress is open to undergraduate students, graduate students, and young professionals of Turkish American heritage who wish to become active in American civic and political life, contribute to U.S.-Turkey relations and the Turkish American community, and advance the TCA mission.

Every fall through this program, participants have the opportunity to expand their knowledge of U.S.-Turkey relations and the political systems of both countries; meet members of Congress, diplomats, and policy experts; and network with peers from across the U.S. Since the program began in 2014, 59 Turkish Americans have attended the Turkish American Youth Leadership Congress. Applications for the Youth Congress open every year in July.

In 2015, 30 young Turkish Americans came away from the TCA Youth Congress inspired to take a more active role in local and national politics and become effective representatives of the Turkish American community. While in Washington, DC, delegates attended meetings and briefings with Turkish policy experts, congressional staffers,

The participants also had the opportunity to network with leaders in U.S.-Turkey relations and with other young Turkish Americans. Throughout the weekend, delegates engaged in an active dialogue on the state of U.S.-Turkey relations and specific issues important to Turkish Americans. They also learned about the role of citizens in policymaking and the steps they could take to be successful advocates.

The delegates also toured the U.S. Capitol and visited the Turkish Ambassador's historical residence, where they received a briefing by Turkish Embassy staff. Their visit to the nation's capital was topped off with a jazz concert at the Kennedy Center, a tour of the monuments on the National Mall, and a visit to the National Portrait Gallery.

For the Youth Congress, TCA received video messages from the Co-Chairs of the Congressional Caucus on U.S.-Turkey Relations and Turkish Americans: Congresswoman Virginia Foxx (R-NC/5th), Congressman Ed Whitfield (R-KY/1st), Congressman Gerry Connolly (D-VA/11th), and Congressman Steve Cohen (D-TN/9th); two prominent Turkish Americans: Cenk Uygur, co-founder of the Young Turks Network and a leading Turkish American political commentator, and Judge Jay Karahan, Harris County/Texas Criminal Court and the highest elected Turkish American official; and Turkish German Parliamentarian Belit Onay, a member of the Green Party in Germany.

TCA - UNIVERSITY OF UTAH TURKISH STUDIES PROJECT

In 2015, TCA continued to fund the [Turkish Studies Project](#) at the University of Utah, which is directed by University of Utah Professor Dr. M. Hakan Yavuz. TCA provided this major [multi-year grant](#) to the University of Utah in 2009 to establish an academic program to examine the origins of modern ethnic cleansing, the collapse of the Ottoman Empire, and the emergence of nation states in the Balkans and the Caucasus. The grant was renewed in 2015 with an expanded geographical focus entitled “The Origins and Contemporary Challenges of Turkic Peoples.” Under the current grant term, the Project aims to explore the past histories and shaping of contemporary Turkic-majority states and their relationships with modern Turkey via scholarly work, community participation, social media, and support for new research.

The Turkish Studies Project in 2015 provided fellowships to graduate students and scholars who are undertaking research about Turkic peoples and states and their relationships with modern Turkey. The program also provided support for them to attend and present at conferences in the U.S., Turkey, and Europe and to translate scholarly material to English. In addition, the Turkish Studies Project held its own conference in Brussels, Belgium to bring together the best scholars in the field. The conference covered two topics, the first of which was Jadidism and its socio-political implications for the Turkic peoples. The second was the nation-building process in the Balkans, with a focus on ethnic cleansing and massacres of the Ottoman population.

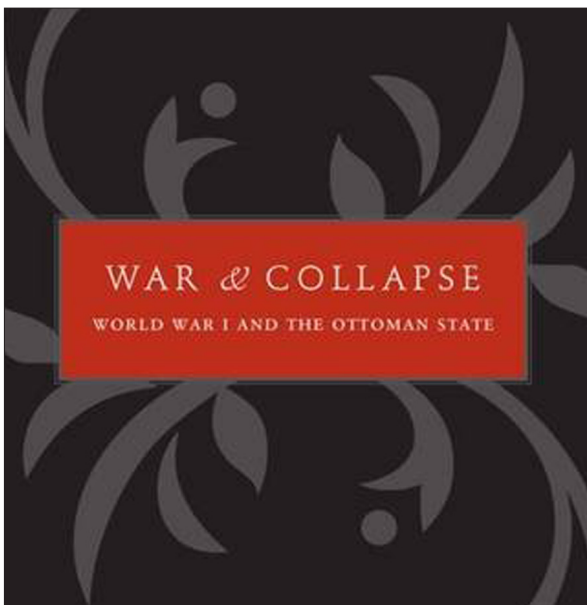

In 2015, a number of academic and journalistic writings composed under the Turkish Studies Project were published or selected for future publication. These works included several chapters of *War and Collapse: World War I and the Ottoman State*, edited by M. Hakan Yavuz with Feroz Ahmad and since published by the University of Utah Press. In addition, Ph.D. fellow Tal Buenos published numerous newspaper articles and several scholarly works, including an article in *Review of Armenian Studies* entitled “Historiography and the Future of Multiculturalism in Europe: Perincek v. Switzerland.” Post-doctoral fellow Brad Dennis secured the publication of his work, “Ideas of Cultural Cleansing from the Balkans to Eastern Anatolia and the Caucasus: How the Balkan Wars Influenced Armenian Revolutionaries.” Another fellow, Perparim Gutaj, conducted archival research and made progress on his dissertation, “Patterns of Ethnic Cleansing in the Balkans.” Also with Turkish Studies Project support, Hakan Erdagoz successfully completed and defended his Ph.D. dissertation, which explored the construction of Turkophobia in Europe by tracing historically shifting discourses of religious diversity in a comparative study of France and Russia. In addition, the Turkish Studies Project supported and promoted a number of other publications and translations in 2015.

TURKISH CANADIAN YOUTH CONGRESS

For the sixth year in a row, TCA provided a grant to support the Council of Turkish Canadians (CTC) Annual Turkish-Canadian Youth Congress. The 8th Annual Turkish Canadian Youth Congress was held October 16–18, 2015 in Toronto, Canada and was entitled, “Participating in Canadian Democracy.”

Over 700 young Turkish Canadians have participated in the annual youth conferences thus far and the 2015 Congress attracted over 50 participants. The event provided a platform for young Turkish Canadians to meet each other and work towards a better understanding of Turkish heritage and history. During the forum, participants gained guidance to make effective contributions to Canada and received tools and information necessary to address and resolve issues important to Turkish Canadians.

Speakers at the 2015 Congress included Turkish Ambassador to Canada Selcuk Unal, retired Ambassador and former member of the Turkish Parliament Dr. Onur Oymen, and former Canadian Ambassador to the UN Paul Heinbecker. Other speakers included Dr. Christopher Gunn of Coastal Carolina University, Dr. Ozay Mehmet of Carleton University, and Ergun Kirlikovali, past president of the Assembly of Turkish American Associations (ATAA). Youth delegates also made presentations. TCA Project Coordinator Kate Costello spoke at the event about the programs of TCA and TCF, congressional outreach, and Turkish American political participation.

SCHOLARSHIPS AND EDUCATIONAL EXCHANGES

• TCA Study Abroad Scholarships for American Students of Minority and Heritage Communities

Through the [TCA Study Abroad Scholarships for American Students of Minority and Heritage Communities program](#), TCA provides up to **100 scholarships per year** for **American students of African, Armenian, Bosnian, Filipino, Hispanic, Macedonian, and Native American** descent who have been accepted to a study abroad program in Turkey, the Turkish Republic of Northern Cyprus, or Bosnia and Herzegovina.

In 2015, TCA awarded a record 90 scholarships, bringing the total number of scholarships awarded to 469 since this program's inception in 2008. American minority students who receive the TCA Study Abroad Scholarship studied in subject areas ranging from engineering to art history, with the most popular subjects being international relations, political science, and history.

Scholarship recipients came from American colleges and universities across the country, the most widely represented institutions being Duke University, Georgia State University, San Diego State University, Spelman College, Syracuse University, the University of California Santa Barbara, the University of Texas at Austin, and Valdosta State University. Finally, the most common Turkish institutions chosen by the students for their study abroad programs were Bahcesehir University, Bogazici University, Koc University, Middle East Technical University, and Yeditepe University.

• TCA Study Tour Grant Program

The [TCA Study Tour Grant Program](#) was established in 2011 to support educational travel programs to Turkey by American universities and educational institutions. It subsidizes participation costs for students and provides a general incentive for institutions to choose Turkey as a study tour destination.

After receiving a record number of applications in 2015, TCA awarded **nine Study Tour Grants** to faculty-led study tour programs organized by American universities. The recipients were SUNY Buffalo State, Evergreen State College, University of Arkansas, Texas A&M University, University of Colorado, University of Nevada-Reno, and the University of Minnesota-Duluth. In total, TCA provided **\$41,350** to benefit **105** students from across the nation who participated in these tours and learned about Turkey through various disciplines including history, art, architecture, and religious studies. This brings the total number of participants to 281 since the program began in 2011.

HERITAGE PARTNERSHIPS

TCA established special [partnerships](#) with the Bosniak and Macedonian communities in the United States to enhance the historical heritage and contemporary bonds of friendship that the Turkish people have with their Balkan neighbors. Over the years, TCA has provided support to the Advisory Council of Bosnia and Herzegovina (ACBH) and to the United Macedonian Diaspora (UMD) to help the two organizations hire professional staff, institute new programs and events, and build their memberships and donor bases.

UMD has grown into an influential voice in the U.S. and globally, representing the interests of Macedonians worldwide. Similarly, TCA's support to ACBH has allowed the organization to grow its presence in Washington, DC. TCA's partnership with ACBH has made it possible for young Bosnian Americans to intern in high profile offices in Washington, DC.

Both UMD and ACBH share offices at TCA's headquarters in Washington, DC. This close proximity allows for the organizations to continue to host joint programs and foster the partnership spirit that Turkish, Macedonian, and Bosnian Americans have developed over the years.

TCA – NATIVE AMERICAN RELATIONS

The Turkish-Native American partnership began in 2008 with TCA's [Study Abroad in Turkey scholarships](#) for Native American students, which TCA continued to provide in 2015. This partnership has been strengthened over the years as a result of several special projects, both economic and cultural, spearheaded by TCA. Overall, TCA's Native American outreach aims to foster ties between Indian Country, Turkish Americans, and Turkey.

As part of this outreach, TCA promoted Turkey-Indian Country ties by participating in the 2015 Reservation Economic Summit in Washington, DC (RES DC), June 15-18. Organized by the National Center for American Indian Enterprise Development (NCAIED), the summit brought together members of Congress, corporations, federal agencies, and tribal businesses. The 2015 theme for RES DC was "Advancing American Indian Enterprise for Growth in U.S. and Global Markets."

TCA sponsored the Global Trade Reception part of RES DC, which featured the Kardelen Turkish Dance Ensemble. TCA also coordinated additional Turkish participation in RES DC on the part of the Turkish Embassy, the Turkish Cooperation and Coordination Agency (TIKA), and the Turkish Heritage Organization (THO). The Turkish International Cooperation and Development Agency (TIKA) sponsored a two-page advertisement in the conference magazine about grants given by TIKA to Oregon's Confederated Tribes of Warm Springs (CTWS) and to Indian farmers in Guatemala, Peru, and Bolivia.

TCA ENGAGEMENT WITH REFUGEES IN TURKEY

TCA President G. Lincoln McCurdy visited camps for Syrian refugees in Viransehir and Midyat, Turkey in June 2015 with a view to highlighting how Turkey is confronting the challenges of one of the worst man-made humanitarian crises facing the world. At the time of McCurdy's visit, Turkey had taken in over 1.7 million refugees fleeing violence in Syria and the surrounding region. Of these refugees, over 200,000 were living in one of 25 temporary protection camps, while 1.5 million were living in Turkish towns and cities. The numbers have continued to increase since that time.

On June 1, McCurdy visited the Prime Ministry Disaster & Emergency Management Authority (AFAD) Viransehir refugee camp. The camp, which opened in August 2013, is built on Turkish government land located near the Ceylanpinar border crossing with Syria. The camp provides various services, including electricity, running water, schools, language lessons, community centers, computer facilities, sewing and weaving centers, grocery stores, and hospitals.

On June 2, McCurdy visited the AFAD Midyat refugee camp, which opened in 2013 and provides similar services to those of the Viransehir camp. While in Midyat, McCurdy toured the camp and surrounding area and met with the camp director. Originally constructed for Assyrian Christian refugees from Iraq, the camp housed over 5,000 Syrian refugees and Iraqi Yazidis at the time of McCurdy's visit.

Since its founding, TCA has supported Turkish American and Turkish Canadian organizations in their efforts to strengthen the Turkish voice in North America through education and civic participation.



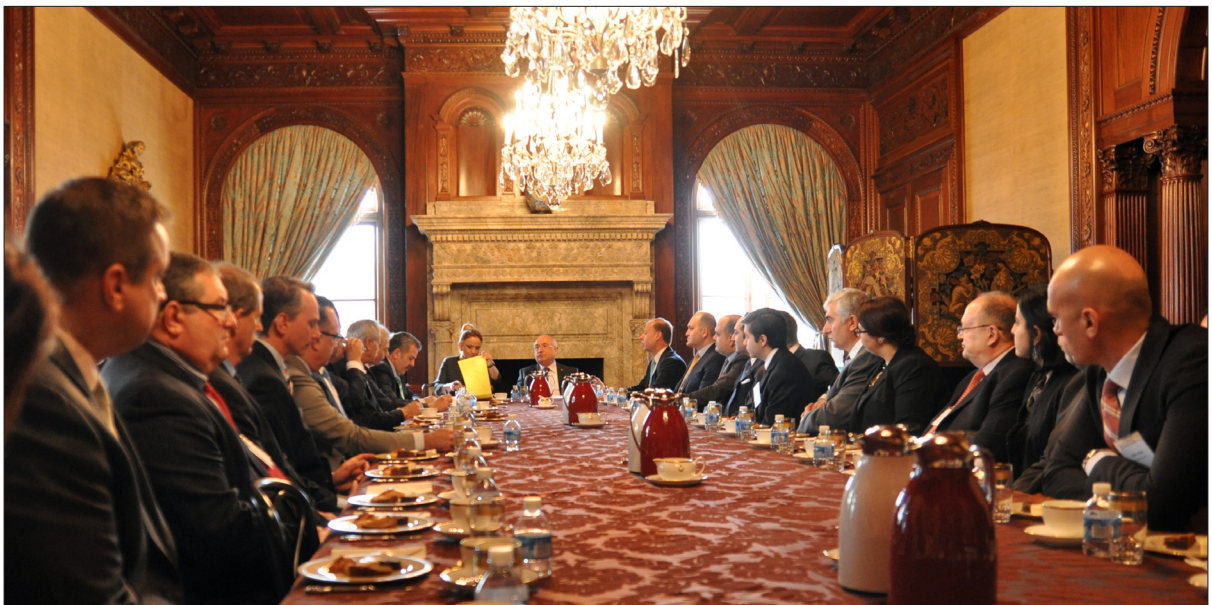

FORUM FOR BUSINESS EXECUTIVES

In March 2015, TCA hosted the first ever business forum on the American political system in Washington, DC for executives of Turkish-owned companies in the U.S., major Turkish American businesses, and interested American companies. Over 30 representatives from companies and business associations took part in the program, which provided an opportunity for participants to learn how to effectively communicate their business issues and interests to elected officials.

As part of the event, Turkish Ambassador Serdar Kilic hosted TCA forum participants and Turkish parliamentarians for a roundtable discussion with Speaker of the Turkish Parliament, H.E. Cemil Cicek. Afterwards at TCA headquarters, Dr. Kemal Kirisci of the Brookings Institution gave the luncheon keynote. Forum participants also had briefings about the 114th Congress, the Congressional Caucus on U.S.-Turkey Relations and Turkish Americans, legal perspectives on corporate political activism, and the activities of Turkish American grassroots organizations. They also heard a presentation from Coca-Cola about how to be good corporate citizens in their communities and the importance of being engaged in the political process.

The group met with eight members of Congress at the U.S. Capitol, including the Co-Chairs of the Turkey Caucus. The group then attended the U.S. Association of Former Members of Congress 18th Annual Statesmanship Awards Dinner, of which TCA was a major sponsor.

SUPPORTING COMMUNITY GROWTH AND CIVIC CONTRIBUTIONS

In 2015, TCA continued to support the Assembly of Turkish American Associations (ATAA), one of the leading Turkish American grassroots organizations. TCA provided a \$20,000 grant to sponsor the ATAA 35th National Leadership Conference in Washington, DC on March 12-14, 2015. Hundreds of Turkish Americans from across the United States participated in the conference, which also included an opportunity for attendees to visit congressional offices.

The U.S. Association of Former Members of Congress (USAFMC) held its 18th Annual Statesmanship Awards dinner on March 25, 2015. TCA supported this event, which brought together hundreds of guests, including former and current members of Congress, ambassadors, corporate and think tank representatives, and Administration officials.

TCA continued its partnership with the Congressional Hispanic Caucus Institute (CHCI) by supporting CHCI's 38th Annual Leadership Conference held in Washington, DC on October 6-8, 2015. CHCI's programs serve more than 1,500 Latinos annually. TCA has worked closely with CHCI for years to promote Turkey as a study abroad destination for Hispanic American students and to increase the number of Hispanic American recipients of TCA's Study Abroad in Turkey Scholarship Program. TCA promoted its scholarships in 2015 at a Study Abroad Panel hosted by CHCI in Washington, DC.

TCA also lent support and expertise to other groups in 2015. TCA briefed a delegation of students from the American Studies program at Bahcesehir University in Istanbul on the American political system during the group's trip to the U.S. TCA also arranged for the Bahcesehir students to tour the U.S. Capitol and organized meetings with members of Congress and their staff. In addition, TCA was a partial sponsor of Turkish Night, hosted by the Turkish Students Association at George Washington University. TCA also supported the American Turkish Association of Washington, DC (ATA-DC). TCA was a co-sponsor and host of ATA-DC's Future Leaders Series, which consisted of several workshops for young professionals about how to utilize social media for personal branding.

STRENGTHENING THE VOICE OF TURKISH AMERICANS

One of TCA's primary objectives is to strengthen the voice of Turkish Americans in public affairs. TCA works to monitor legislation and issues discussed in Congress that concern the community, and it activates the TCA Action Alert Center to prompt Turkish Americans to contact their members of Congress when necessary.

The TCA [Action Alert Center](#) is available free of charge to Turkish American organizations and partners of TCA. TCA also regularly provides information and analysis to members of Congress and their staff on issues related to Turkey and U.S.-Turkey relations through TCA Issue Papers sent via fax and email bulletins as well as through face-to-face meetings. In 2015, 16 [TCA Issue Papers](#) were published.

SUPPORTING THE TURKEY CAUCUS ON U.S.-TURKEY RELATIONS AND TURKISH AMERICANS

TCA works with the Turkish American community to increase the membership of the **Congressional Caucus on U.S.-Turkey Relations and Turkish Americans** (the Turkey Caucus).

In 2015, the [Turkey Caucus](#) expanded its membership to **148**, representing **42 U.S. states** and all **six territories**. With members from both the U.S. Senate and the U.S. House of Representatives, it is the second largest bicameral ethnic/national caucus in Congress.

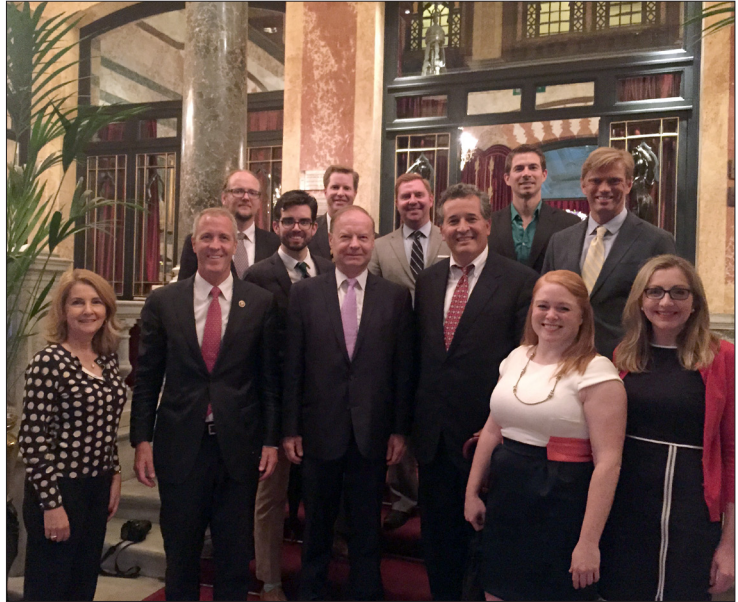
TCA engaged members of the Turkey Caucus on a regular basis throughout the year. It sponsored numerous events relating to the mission of the Turkey Caucus, including facilitating the participation of Turkey Caucus members in Turkish American events, hosting meetings with members of the Turkish American community, promoting the work of its individual members, and integrating such TCA programs as its scholarship program and Washington Summer Internship Program into the members' own constituent services.

TCA also continued to publish a bi-annual bulletin specifically for members of the Turkey Caucus, meant to inform them of important developments in the U.S.-Turkey agenda and on issues of significance to the Turkish American community.

17TH TCA CONGRESSIONAL DELEGATION TO TURKEY

Since 2009, TCA has taken more than 170 members of Congress and senior staffers to Turkey and surrounding countries and has become one of the leading organizations sponsoring foreign congressional travel.

TCA's 17th Congressional Delegation visited Turkey and Bosnia and Herzegovina from May 25-31, 2015. Two members of Congress participated on the trip, Congressman Sean Maloney (D-NY/18th) and Congressman Juan Vargas (D-CA/51st). Six Chiefs of Staff also participated from the offices of Congressman Tom MacArthur (R-NJ/3rd), Congressman Ryan Zinke (R-MT/At Large), Congressman Tom Emmer (R-MN/6th), Congressman Glenn Grothman (R-WI/6th), Congressman Carlos Curbelo (R-FL/26th), and Congressman Sean Maloney. The 2015 delegation first visited Istanbul, where participants held high-level meetings with U.S. and Turkish officials and also met with members of the press, academia, and the business community. The group also took a one-day trip to Canakkale and the sites of the World War I Battle of Gallipoli. Participants were briefed on the strategic and economic importance of the Dardanelles Straits. The group also commemorated the 100th anniversary of the Battle of Gallipoli by visiting several key battlefields as well as the monuments dedicated to Turkish, British, Australian, and New Zealand soldiers who died during the battle. The visit highlighted the battle site's significance as a place of reconciliation, friendship, and international peace.

The de-mining project was undertaken by the Marshall Legacy Institute (MLI) with support from a \$100,000 [humanitarian grant](#) from TCA, which was matched by a grant from the Office of Weapons Removal and Abatement of the U.S. State Department (PM/WRA).
